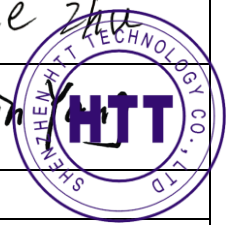

R=distance to the center of radiation of the antenna
