Band12-10MHz-16QAM-23060-50RB#0

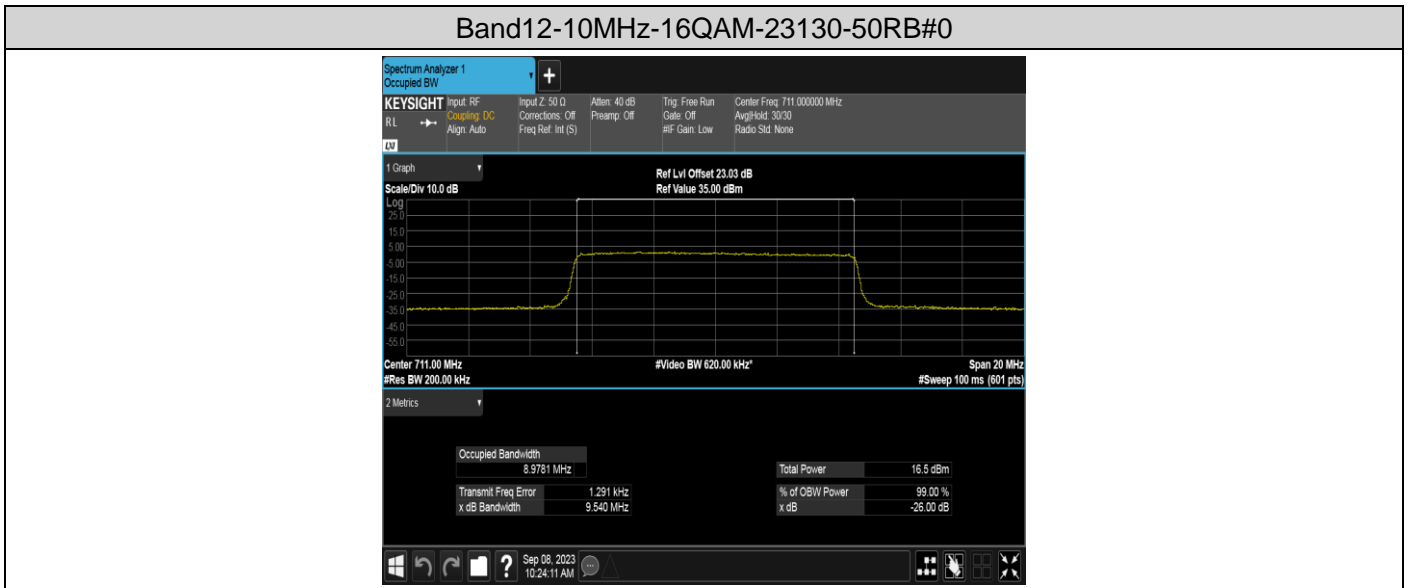

Band12-1.4MHz-QPSK-23095-1RB#0-Range1:30~1000MHz

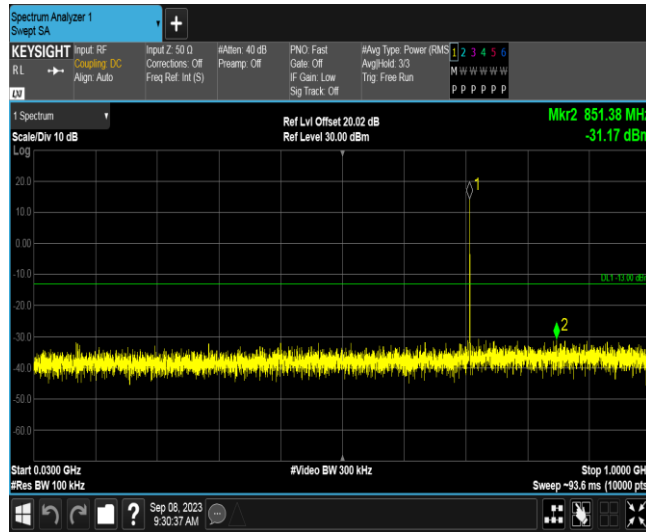
