$$S = \frac{PG}{4\pi r^2} = \frac{EIRP}{4\pi r^2}$$

where:

S = power density

P = power input to the antenna

G = power gain of the antenna in the direction of interest relative to an isotropic radiator

R = distance to the center of radiation of the antenna
