If you had a mouth or gum operation in the last two months, please consult your dentist before using this toothbrush.


If your teeth bleed after using this toothbrush please consult your dentist.

Your dentist recommends that you replace your electric toothbrush head every 2-3 months.

Wireless charging function introduction:
The principle of wireless charging is that the wireless charging device transmits the energy to the charging terminal device through near-field induction, and the terminal device converts the received energy into electric energy and stores it in the battery of the device.

The principle of energy transmission is inductive coupling, which can ensure that there is no exposed conductive interface. It can not only eliminate the messy entanglement lines between devices, but also be safer for electronic devices such as electric toothbrushes that often contact with conductive media such as liquids.

04 / Battery processing



Do not attempt to replace the battery by yourself, lest the waterproof performance or internal structure of the product be damaged.
