Band71-5MHz-QPSK-133297-1RB#0-Range1:30~1000MHz

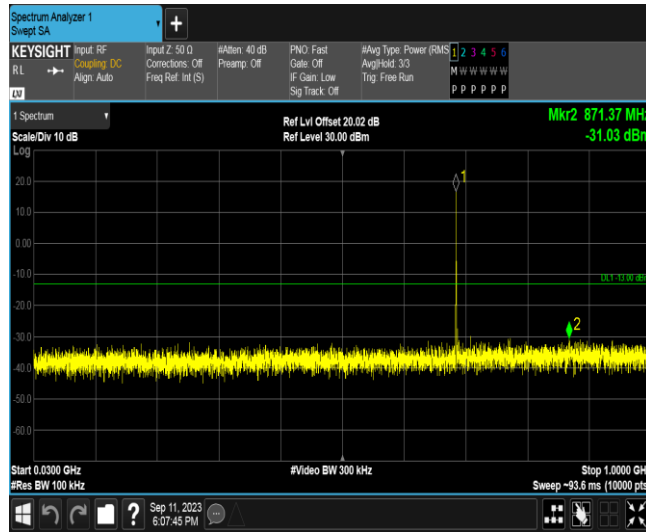

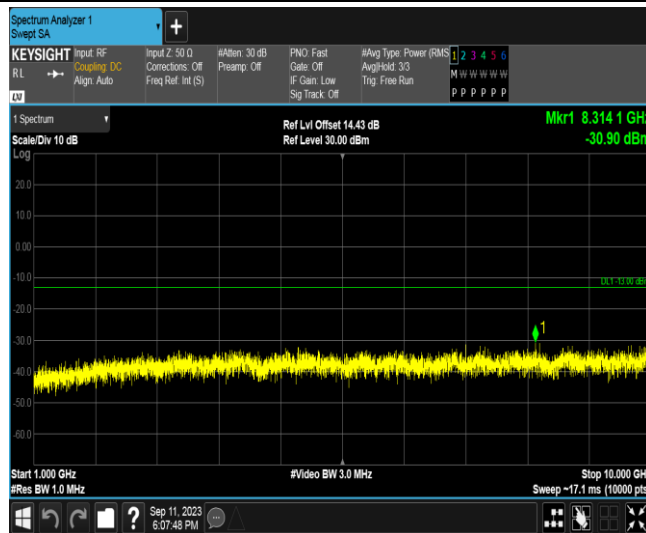
