- DVI* or HDMI monitor

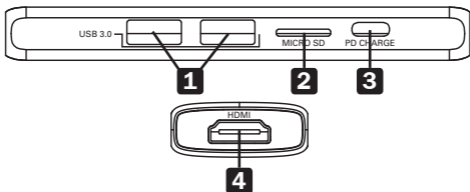

- Supports USB DisplayPort Alternate Mode for connecting an HDMI monitor via USB-C or Thunderbolt 3 port
- Supports connection of DVI monitor via HDMI to DVI adapter (see **Optional Accessories**)
- HDMI port supports video resolutions up to 3840 x 2160 (4K x 2K) @ 30 Hz
- USB-A hub ports support data transfer rates up to 5 Gbps
- Micro SD memory card slot allows external memory access via USB-C or Thunderbolt 3 port

- USB-C port supports power input up to 20V 3A (60W) and data transfer rates up to 480 Mbps
- 8W of USB-C input power dedicated to unit and USB-A ports; remaining power goes to connected USB-C device

- 1 USB 3.0 Ports (Female):** connect up to 2 USB peripherals
- 2 Micro SD Memory Card Slot:** insert Micro SD memory card
- 3 USB-C Data/PD Charging Port (Female):** connect device to USB-C charger or USB-C device
- 4 HDMI Port (Female):** connect HDMI monitor
USB-C Plug (Male) (not shown): connect to USB-C or Thunderbolt 3 device

Installation

Notes:

- *When connected to power through the USB-C PD charging port, 8W is dedicated to the docking station and connected USB peripherals. Remaining power is used to charge the connected USB-C device.*
 - See **Optional Accessories** section for suggested cables.
- 1.** Connect built-in USB-C cable to USB-C or Thunderbolt 3 port on your laptop, tablet or other device.
 - 2.** Connect HDMI port to HDMI port on a monitor using an HDMI cable.
 - 3.** Connect USB 3.0 hub ports to USB peripherals.
 - 4.** Insert Micro SD card into memory card slot to access external memory.
 - 5.** Charge device by connecting its USB-C charger to adapter's USB-C PD charging port. The port can also be used to connect a USB-C peripheral.
