2023 NARTA LAITHWAITES COOKING PROMOTION TERMS AND CONDITIONS

- 1. Information on how to claim and details of the Bonus Product (as defined below) form part of these Terms and Conditions. Participation in the offer is deemed to constitute acceptance of these Terms and Conditions.
- 2. The offer is open to Australian residents over the age of 18. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to claim ("Claimant"). Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child, or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
- 3. The offer commences on 1/3/23 and closes for purchases at 11.59pm (AEDT) on 31/3/23 ("**Purchase Period**"). Claims open 1/3/23 and close at 11:59pm AEST on 31/5/23 ("**Claim Period**").
- 4. To be eligible to submit a claim, Claimants must purchase a-new 90cm Oven, Stove, Upright Cooker and/or Rangehood product ("Eligible Product"), from a Participating Retailer (either in-store or online) in Australia within the Purchase Period while stocks of Eligible Products last. Models may vary by store. Refurbished, second-hand Eligible Products or purchases made from non-approved retailers (either in-store or online) are excluded from this offer. A Claimant must have fully paid for the Eligible Product before they are eligible to submit a claim. Where an Eligible Product is returned to the Participating Retailer, the Claimant is not entitled to the Bonus Product.
- 5. A "Participating Retailer" means any of the following:

- 6. "Eligible Product(s)" see Annexure A.
- 7. To claim, a Claimant must undertake the following steps during the Claim Period:
 - Visit https://cookingpromo.com.au/ and follow the prompts to the promotion claim page;
 - Input the requested details (including full name, mailing address, valid email address, mobile number and model number of the Eligible Product, the date the Eligible Purchase was made and the Participating Retailer) and upload a copy of the purchase receipt for the Eligible Purchase; and then

• Submit the fully completed online claim form.

The claimant will then receive an email from the Promoter confirming that their claim has been submitted and is subject to verification. Successful claimants will then receive a second email from the Promoter confirming their claim is valid (has been approved). Claimants will then receive further communications from Laithwaites when the chosen wine order has been received and when the order has been dispatched. Claimants will receive an email from the Promoter if more information is required at any time during the claim process.

If a Claimant does not have access to the internet or has questions regarding the promotion, they can call 1800 285 285 for clarification or to submit a claim over the phone.

- 8. Upon submitting the online claim form in accordance with the above, and subject to receipt of a valid purchase receipt, each claim will be validated by the Promoter within 5 working days.
- 9. Under the offer, eligible Claimants can claim one (1) Bonus Product per Eligible Product purchased, where up to three (3) Eligible Products can be purchased per person during the Purchase Period. For example, a Claimant may purchase an oven, a cooktop and a rangehood from the list of Eligible Products, where the value of the wine gift is dependent on the individual price paid (including GST) for each product.
- 10. Claimants must retain their original purchase receipt(s) for all claims as proof of purchase. Failure to produce the proof of purchase for any claim when requested may, in the absolute discretion of the Promoter, result in invalidation of a Claimant's claim and forfeiture of any right to a Bonus Product (as outlined below). Any substitute Bonus Product shall not have a value of less than the advertised Recommended Retail Price (RRP).
- 13. Delivery of Bonus Products will only be made to valid postal addresses within Australian states or territories.
- 14. Incomplete or illegible claim forms or Purchase Receipts will be deemed invalid. The Promoter shall not be liable for any official claim form that is late or has been lost, stolen, forged, misdirected, or damaged.

- 15. A maximum of 9 weeks should be allowed for delivery of the Bonus Product from the receipt of a valid claim. - 16. The Promoter's decision is final, and no correspondence will be entered into.
- 17. The Bonus Product will be delivered by third party carriers. If a recipient is not at home when a delivery arrives and they do not give specific delivery instructions, the delivery driver will leave a card indicating that they were unable to deliver your wine, with details on how to go about receiving your missed case.
- 18. Nothing in these terms and conditions limits, excludes, or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the State and Territories of Australia ("Non-Excludable Guarantees"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees, and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the offer.
- 19. Bonus Products are not transferable or exchangeable and cannot be redeemed for cash.
- 20. Any cost associated with accessing the promotional website is the Claimant's responsibility and is dependent on the Internet service provider used. The use of any automated claim software or any other mechanical or electronic means that allows a Claimant to automatically claim repeatedly is prohibited and will render all claims submitted by that Claimant invalid.
- 21. If this offer is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any Claimant; or (b) to modify, suspend, terminate or cancel the offer, as appropriate.
- 22. The Promoter collects personal information ("PI") in order to conduct the promotion and may, for this purpose, disclose such PI to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to Australian regulatory authorities.. Entry is conditional on providing this PI. The Promoter will also use and handle PI as set out in its Privacy Policy, which can be viewed at narta.com.au/privacy-policy. In addition to any use that may be outlined in the Promoter's Privacy Policy, the Promoter and associated promotional partners including Laithwaites may, for an indefinite
