Band2-1.4MHz-16QAM-18607-6RB#0

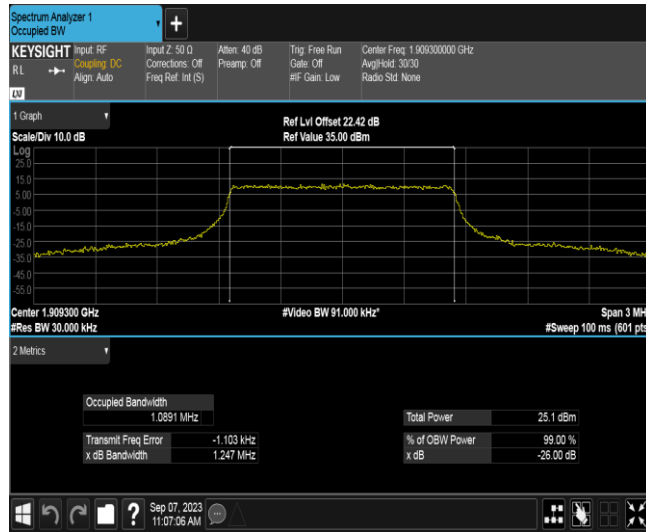

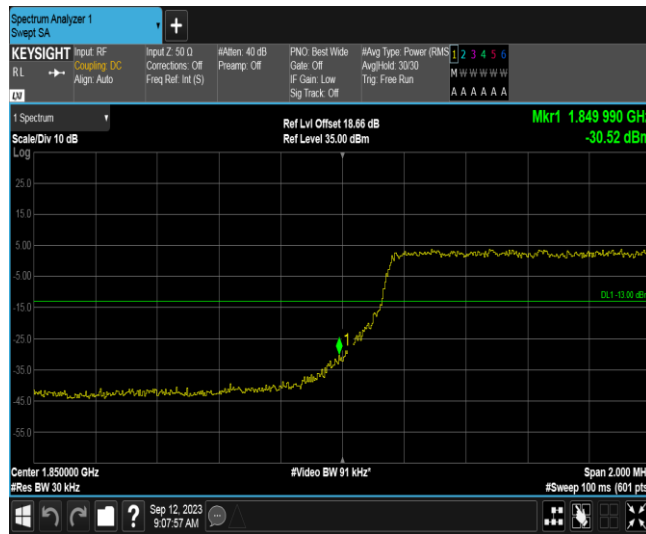


Band2-1.4MHz-QPSK-18607-1RB#5

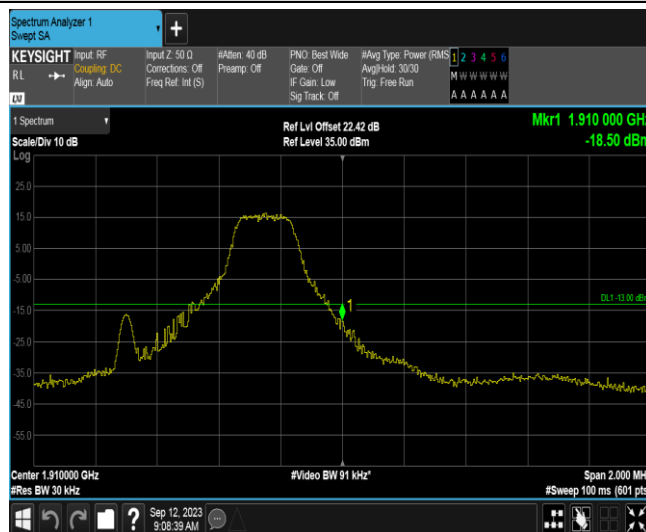

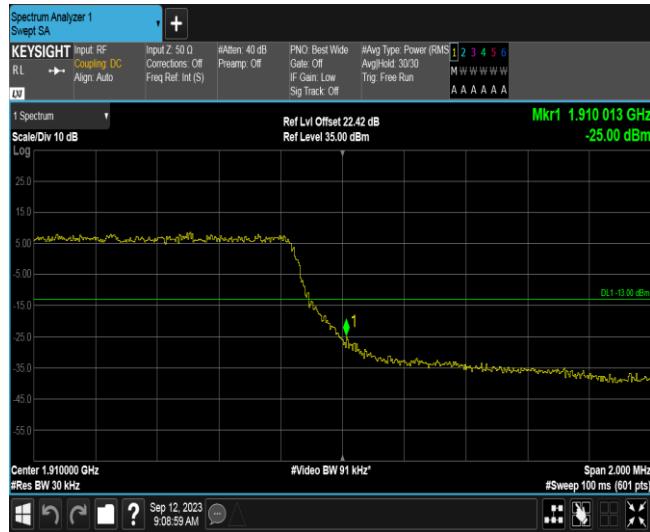

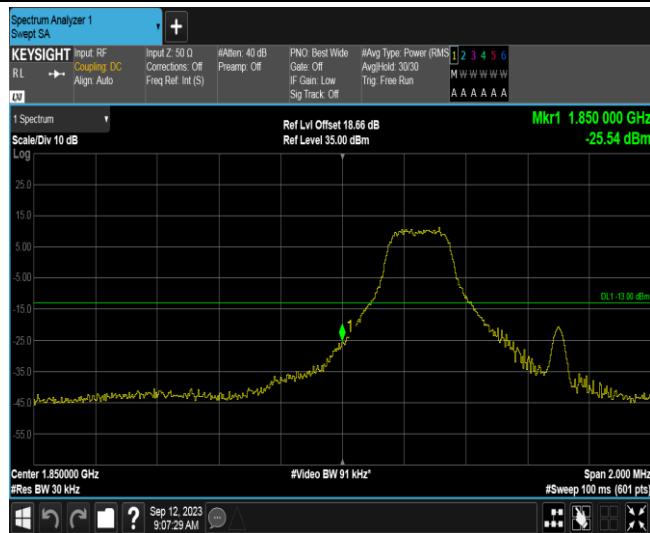
