### **Personal / Directors Guarantee**

<u>IN CONSIDERATION</u> of Lenoxx Electronics (Australia) Pty Ltd ("**Lenoxx**") at the request of the Guarantor (as is now acknowledged) supplying and continuing to supply goods and/or services to the Company or Business ("Customer") named on the front of this Credit Application.

### I (also referred to as the "Guarantor/s") UNCONDITIONALLY AND IRREVOCABLY:

- 1. **GUARANTEE** the due and punctual payment to Lenoxx of all moneys which are now owing to Lenoxx by the Customer and all further sums of money from time to time owing to Lenoxx by the Customer in respect of goods supplied or to be supplied by Lenoxx to the Customer or any other liability of the Customer to Lenoxx, and the due observance and performance by the Customer of all the obligations contained or implied in any contract with Lenoxx. If for any reason the Customer does not pay any amount owing to Lenoxx the Guarantor will immediately on demand pay the relevant amount to Lenoxx.
- 2. **HOLD HARMLESS AND INDEMNIFY** Lenoxx on demand as a separate obligation against any liability (including but not limited to damages, costs, losses and legal fees (as defined hereunder in paragraph (b) hereof)) incurred by or assessed against Lenoxx in connection with:
  - (a) the supply of goods and/or services to the Customer; or
  - (b) the recovery of moneys owing to Lenoxx by the Customer including the enforcement of this Guarantee, and including but not limited to Lenoxx costs of collection and legal costs calculated on a solicitor and own client basis: or
  - (c) moneys paid by Lenoxx with the Customer's consent in settlement of a dispute that arises or results from a dispute between, Lenoxx, the Customers, and a third party or any combination thereof, over the supply of goods by Lenoxx to the Customers.

### I FURTHER ACKNOWLEDGE AND AGREE THAT

- 3. This Guarantee shall constitute an unconditional and continuing Guarantee and Indemnity and accordingly shall be irrevocable and remain in full force and effect until the whole of moneys owing to Lenoxx by the Customer and all obligations herein have been fully paid satisfied and performed.
- 4. This Guarantee shall bind each of the signatories.
- 5. The term "Guarantor" whenever used in this Guarantee shall, if there is more than one person named as Guarantor, mean and refer to each of them individually and all of them together unless the context otherwise requires, and the obligations and agreements on the part of the Guarantor contained in this Guarantee shall bind them jointly and severally.
- 6. I/we irrevocably authorise Lenoxx to obtain from any person or company any information which Lenoxx may require for credit reference purposes. I further irrevocably authorise Lenoxx to provide to any third party, in response to credit references and enquiries about me or by way of information exchange with credit reference agencies, details of this Guarantee and any subsequent dealings that I may have with Lenoxx as a result of this Guarantee being actioned by Lenoxx.

### **TERMS AND CONDITIONS**

### 1. PAYMENTS

- 1. All goods supplied by Lenoxx Electronics (Aust) Pty Ltd ("Lenoxx") or approved agents during any calendar month must be paid for in full by the last trading day of the following month.
- 2. Lenoxx will render to the Customer a monthly statement of the account in respect to the preceding month.
- 3. A late fee of \$20.00 or interest calculated at the rate of 1.5% per month, whichever is greatest, will be billed to a customer who has not paid their account in full by the agreed terms as stipulated in clause 1 of the Terms and Conditions.
- 4. Credit Card payments may incur a service fee.
- 5. When accounts are opened in the names of more than one person, all named persons are jointly and separately liable to pay the account.
- 6. Accounts are deemed to be unpaid until such time as payments have been fully cleared by the Customer's' bank.
- 7. If at any time an account becomes overdue, the whole of the account balance shall, at the discretion of Lenoxx become immediately payable.
- 8. Lenoxx may at any time terminate or suspend the Customer's right to purchase goods on a credit account.
- 9. Lenoxx has the right to refuse or partially accept orders for goods from the Customer.
- 10. Payment of accounts shall firstly be applied to any interest charged and against previous invoices.
- 11. Goods will not be supplied to overdue accounts until such time as the whole amount payable is received and funds cleared by the supplier.
- 12. All government and bank charges associated with the applicant's account will be debited to the applicant's account.
- 13. Any failure by Lenoxx to insist upon strict performance of any term or condition of this agreement shall not be deemed a waiver thereof or of any rights Lenoxx may have.
- 14. To secure Payments of all monies which may become payable by the Customer to Lenoxx, the Customer hereby charges with the due payment of those monies all of the Customer's interest in real property both present and future, and the Customer consents to the Company lodging a caveat or caveat noting its interest pursuant to such charge. The Customer hereby agrees to indemnify the Company for all legal costs and fees in respect to such charge and caveat.

#### 2. RETURNS & CREDIT

Returns and credits are only accepted if authorized by Lenoxx or by one of its approved agents, and are notified to Lenoxx within 7 days of receipt of goods. Goods may only be returned by a carrier approved by Lenoxx or its agents. A handling charge may apply to returned goods. A credit will not be issued without a corresponding Invoice number. Lenoxx reserves the right to not issue a refund cheques. A refund is only issued as a store credit and valid for 12 months.

### 3. RETENTION OF TITLE AND RISK OF LOSS

- 1. Ownership of goods does not transfer to the Customer until payment in full is received by Lenoxx and cleared.
- Risk in the goods purchased passes to the Customer upon delivery.
- The goods shall remain the sole and absolute property of as the legal and equitable owner until such time as the purchaser has paid all monies due in respect of all goods supplied.
- 4. Unless and until such time as payment of all monies due in respect of all goods supplied has been paid by the customer, the customer undertakes to store the goods which makes them readily definable as the said goods.
- 5. The right of the customer to hold and sell the goods supplied by Lenoxx Electonics Aust Pty Ltd will immediately cease if an administrator or controller within the meaning of section 9 of the Corporation Law (Australia) or similar officer is appointed to all or any assets or undertaking of the customer is deregistered. In any such case, and without the need for notice or demand by Lenoxx Electonics Aust Pty Ltd, the customer acknowledges that any sale or purported sale of the goods supplied will not in the ordinary course of the business of the customer and the proceeds of any goods sold in such circumstances will, to the extent of the money owing be held on trust for Lenoxx Electonics Aust Pty Ltd by the administrator, controller or similar officer as the case may be, or if there is no such officer, by the customer.
- 6. Unless and until such time as payment of all monies due in respect of all goods supplied has been paid by the Customer, Lenoxx or its duly appointed agent may for the purpose of examination or recovery of it's goods enter upon any premises where they are stored or where they are reasonably thought to be stored.
- **4. GOVERNING LAW**: This agreement is governed by the laws of the State of Victoria and the parties agree to submit to the exclusive jurisdiction of the courts of Victoria.
