



2.5 EUT Operation Test Setup

For Bluetooth v4.1 LE function, the engineering test program was provided and enabled to make EUT continuous transmit/receive.

For AC power line conducted emissions, the EUT was set to connect with the WLAN AP under large package sizes transmission.

2.6 Measurement Results Explanation Example

For all conducted test items:

The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuator factor between EUT conducted output port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly the EUT RF output level.

Example:

The spectrum analyzer offset is derived from RF cable loss and attenuator factor.

Offset = RF cable loss + attenuator factor.

Following shows an offset computation example with cable loss 5.0 dB and 10dB attenuator.





3.2 Peak Output Power Measurement

3.2.1 Limit of Peak Output Power

For systems using digital modulation in the 2400-2483.5MHz, the limit for peak output power is 30dBm. If transmitting antenna of directional gain greater than 6dBi is used, the peak output power from the intentional radiator shall be reduced below the above stated value by the amount in dB that the directional gain of the antenna exceeds 6 dBi. In case of point-to-point operation, the limit has to be reduced by 1dB for every 3dB that the directional gain of the antenna exceeds 6dBi.





- 4. Make the measurement with the spectrum analyzer's resolution bandwidth (RBW) = 3 kHz. Video bandwidth VBW = 10 kHz In order to make an accurate measurement, set the span to 1.5 times DTS Channel Bandwidth. (6dB BW)
- 5. Detector = peak, Sweep time = auto couple, Trace mode = max hold, Allow trace to fully stabilize. Use the peak marker function to determine the maximum power level.
- 6. Measure and record the results in the test report.
- 7. The Measured power density (dBm)/ 100kHz is a reference level and used as 20dBc down limit line for Conducted Band Edges and Conducted Spurious Emission.



PSD 100kHz Plot on Channel 39







PSD 3kHz Plot on Channel 19







- 1. The testing follows FCC KDB Publication No. 558074 D01 DTS Meas. Guidance v03r03.
- 2. The RF output of EUT was connected to the spectrum analyzer by RF cable and attenuator. The path loss was compensated to the results for each measurement.
- 3. Set to the maximum power setting and enable the EUT transmit continuously.
- 4. Set RBW = 100 kHz, VBW=300 kHz, Peak Detector. Unwanted Emissions measured in any 100 kHz bandwidth outside of the authorized frequency band shall be attenuated by at least 20 dB relative to the maximum in-band peak PSD level in 100 kHz when maximum peak conducted output power procedure is used. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, the attenuation required under this paragraph shall be 30 dB instead of 20 dB per 15.247(d).
- 5. Measure and record the results in the test report.
- 6. The RF fundamental frequency should be excluded against the limit line in the operating frequency band.



Low Band Edge Plot on Channel 00






Conducted Spurious Emission Plot on Bluetooth LE 1Mbps GFSK Channel 00




For radiated emissions below 30MHz









3.6.5 Test Result of AC Conducted Emission





3.7 Antenna Requirements
